Promotions

Eighteen sergeants were promoted to lieutenant and twenty-six officers were promoted to sergeant during a ceremony on December 20 in the headquarters building auditorium. Acting Commissioner Hamm presided over the ceremony. During his remarks, Commissioner Hamm emphasized the value of "accountability-driven leadership" in the department and spoke of the importance of doing the right thing, at all





times, on and off the job. Following is an excerpt of the Commissioner's speech.

"It's important to recognize that doing the right thing is a lot more than not doing the wrong thing. This is really our challenge as I see it: to go beyond our good intentions and make good things happen. As our Mayor has said so many times in every corner of our city, 'More unites us than divides us.' I ask you to adopt that sentiment, embrace it, and apply it to the approach you take to your new responsibilities. It will serve you well."

Detective Thomas G. Newman



On December 28, Acting Police
Commissioner Leonard Hamm held a moving
ceremony in honor of the two detectives and two
prosecutors who led the investigation into the 2002
murder of Detective Thomas G. Newman. All
three suspects in the case have now been
convicted of first degree murder. Two of them
have been sentenced to life in prison, the third is
awaiting sentencing.

During the ceremony, acting Commissioner Hamm presented Detective Corey Alston and Sgt. Richard H. Petrey II with Bronze Stars, and Assistant State's Attorneys Matthew Fraling and Donald Giblin with certificates of special appreciation. Detective Newman's mother, sister and young daughter were among those in attendance. We will never forget.

Heroin Ring Busted

After three weeks of surveillance and undercover drug buys, 40 detectives from the Organized Crime Division and the Northwest District made simultaneous raids on the morning of Saturday, December 8. In addition to the 11 people who were arrested, the officers seized about \$40,000 in cash, numerous packages of high-grade heroin with a street value of approximately \$80,000, two computers, a moneycounting machine and a long-barreled .44 Magnum. Two of the suspects arrested were identified as high-ranking members of the heroin ring. Fantastic work!

Flexing Their Muscle

The Western District Flex Team A, with the help of Flex Team C, executed three search and seizure warrants on January 10. Eight people were arrested and the following was seized: 100 units of crack cocaine, 38.9 grams of crack cocaine, \$319 in cash and ammunition. Job well done. Keep pushing!

Many Medals

There have been two Medals Day ceremonies in the past few weeks. The first one, which was held on January 28, honored 62 officers, including 24 who



received the Bronze Star for Valor, the department's highest honor. The second ceremony, on February 18, recognized the efforts of 34 officers (25 of whom received Bronze Stars) and 10 Baltimore City residents. Congratulations, and thank you, to all.



Job Very Well Done



On March 25, Police Officer (now Sergeant) Sean Harrison of the Northern District conducted a car stop in the 400 block of East 28th Street. Three people were inside a blue and white conversion van. A warrant check was done on the driver, which resulted in the driver being arrested on a CDS warrant.

Instead of ending the investigation there, however, Officer Harrison began to field interview the van's other occupants. Although warrant checks turned up negative, Officer Harrison felt that the occupants' nervousness and conflicting stories warranted further investigation. Officer Harrison soon determined that one of the suspects had given a false name and was wanted in Baltimore County for several armed robberies. Still not satisfied, Officer Harrison contacted BPD's citywide robbery unit and learned that the suspect was also wanted for several bank robberies in Baltimore City, one of which was committed just days before the car stop. The suspect was then arrested, at which time Officer Harrison found a note in the suspect's pocket that read "This is a holdup." Another armed robbery had apparently just been averted.

Closing Down the Ranch

On July 22, the Housing Authority of Baltimore City revoked the multiple family dwelling license of the Pall Mall Apartments on Pimlico Road, a notorious housing complex known to many as "The Ranch." This was the first license revocation under the city's new Property Based Crime Solutions Program (PBCS), which provides a one-stop shop for nuisance abatement in Baltimore City and creates a new and improved way of dealing with and resolving nuisance properties. A hearing officer in the case shut down The Ranch after determining that the property was being used "for the purposes of drug trafficking and other criminal activity," and that the owner "knew that the properties were being used for these purposes and failed to take appropriate action."

OCD Does it Again, and

Again



The Baltimore Police Department's Organized Crime Division continues to do what it does best take big bites out of Baltimore City's illegal narcotics trade. As of September 28, OCD had served more than 1022 search and seizure warrants, seized 523 guns, 152 kilos of cocaine, 28 kilos of heroin and 3044 pounds of marijuana, and confiscated more than eight million dollars in cash.

The unit's latest major initiative was completed on September 27. That's when a three-month long investigation culminated in the seizure of more than 200 pounds of marijuana and \$178,000 in cash, as well as the arrests of five people who were supplying marijuana to the northwest, northern and eastern sections of the city. Outstanding work!

A Reminder

Baltimore Police Grab One of

America's Most Wanted



Jamel Stevens had robbed 30 New York City hair-braiding stores earlier this year when he suddenly disappeared at the end of April. Fast-forward three months to August 9 and head south two hundred miles to West North Avenue here in Baltimore. That's when

and where another hair braiding store was robbed at knifepoint. Detectives working the case developed sources who identified the suspect as a homeless man. Detective Alan Savage eventually found Stevens at Mercy Hospital, where Stevens had gone to be treated for a toothache. When confronted, Stevens gave Det. Savage various dates of birth, and the only identification he had with him was a New York-issued social security number. Undeterred, Det. Savage then called his counterparts at the New York Police Department, who knew from the sound of the crime that the man in custody was, in fact, the infamous braid store bandit. Stevens is now being held at Central Booking. If the story sounds familiar, perhaps you saw the recent episode of America's Most Wanted that featured Stevens's crime spree. Attacking the Narcotics Trade from Every Angle

On August 3, Detective David Shields, along with members of the Western District Drug Unit, executed a search and seizure warrant at Tiffany's Mart on West Fayette Street, where they found a large cache of packaging materials. More than 47 boxes of packaging material with an estimated street value of over \$20,000 was seized, which should serve as a reminder that trafficking in any aspect of the drug trade will simply not be tolerated in Baltimore.

Following Tips

On August 17, members of the Northeastern District Flex Operations Unit received information about a substantial amount of marijuana being stored inside an apartment in the Northwood Apartment complex off Loch Rayen Boulevard.



An investigation was initiated and a search and seizure warrant was obtained. When they got into the apartment, officers found more than 75 pounds of marijuana in the floor of the rear bedroom.

An additional search and seizure warrant was then obtained for a house in the Woodlawn area of Baltimore County. The execution of that warrant yielded information that could play a major role in the prosecution of the case.

Job Well Done

On August 3, members of the Western District and Southwestern District Operations Units conducted an initiative in areas that had recently been affected by violent crime. The initiative primarily focused on the North Avenue corridor from Monroe Street to Poplar Grove Street. As a result of the initiative, 50 people were arrested and a total of 28 car stops, 61 stop and frisks, 67 warrant checks, and 2 search and seizure warrants were executed. One of the search and seizure warrants was executed at a business where 43 cases of narcotics packaging materials were seized. What's more, the initiative produced valuable information regarding 3 homicides and 3 non-fatal shootings.

Officer of the Month

Officer Michael Reynolds was chosen as the Southwestern District Officer of the Month for July 2005. Sergeant Michael Guzman reports that in the 31 days of July, Officer Reynolds made 15 arrests, responded to 103 calls for service, issued 26 civil citations and 2 criminal citations. His productivity was all the more remarkable when you consider that Officer Reynolds also took 10 vacation days in July; 10 well-earned vacation days.
